THE COMPLAINANT STATES that on or about the 17 day of June, 2020  
at or near Ketchikan in the First Judicial District,  
State of Alaska, the above named Defendant did unlawfully commit the offense of Escape In the Second Degree,  
when without lawful authority, he/she

removed himself/herself from

a correctional facility while under official detention for a misdemeanor; AS 11.56.310(a)(1)(A)

official detention for a felony or for extradition; or AS 11.56.310(a)(1)(B)

official detention and, during the escape or at any time before being restored to official detention, he/she possessed on or about oneself a firearm;

AS 11.56.310(a)(1)(C)

violated AS 11.56.340 and, during the time of the unlawful evasion or at any time before being restored to official detention, he/she possessed on or about his/her person a firearm; or

AS 11.56.310(a)(2)

While under official detention for a felony

removed, tampered with, or disabled the electronic monitoring equipment; or

AS 11.56.310(a)(3)(A)

without prior authorization, left his/her residence or other place designated by the commissioner of corrections or the commissioner of health and social services for service by electronic monitoring.


Probable Cause Statement: On 06/17/2020, at approximately 1543 hours, Samantha Wright escaped from the Ketchikan Correctional Facility by pretending to be another inmate in her cell who resembled her who was being released. The inmates were wearing facemasks due to Covid-19 precautions. Wright not only impersonated the other inmate, but also forged the inmate's signature on release documents. Wright was being held on three charges: 1) Fail to appear for hearing where the original charge was Theft 4, cross reference court case 1KE-20-00255CR; 2) Fail to appear for hearing where the original charge was Theft 3, cross reference court case 1KE-20-00272CR; and 3) Fail to appear for hearing where the original charge was Theft 2, cross reference court case 1KE-20-00320CR. A warrant for her arrest is being requested.
