Council Seat F: (3-Year Term)

Everett Cook – 62

Lee Burger (incumbent) is hereby elected to Council Seat F, with a vote of 126

Council Seat G: (3-Year Term)

Shane Nyquest – 152
Bradley Clark – 36

Shane Nyquest is hereby elected to Council Seat G, with a vote of 152
