## 2 Count I

3 That in the First Judicial District, State of Alaska, on or about December 5, 2021,  
4 at or near Metlakatla, ISAAC G. HENDERSON, with the intent to commit the crime of  
5 murder in the first degree, engaged in conduct which constituted a substantial step toward  
6 causing the death of another person; to wit: Tyler Henderson.

7 All of which is an unclassified felony offense, being contrary to and in violation of  
8 AS 11.31.100 / AS 11.41.100(a)(1)(A), and against the peace and dignity of the State of  
9 Alaska.

10 STATEMENT OF PROBABLE CAUSE

11 The undersigned swears that the following is based on information contained in  
12 the Metlakatla Police Department Report for Case No. 2021-3231. The Metlakatla Police  
13 Department received a call at 3:12 a.m., on December 5, 2021. The caller reported that  
14 Isaac Henderson shot his brother, Tyler Henderson, with a 40 caliber semi-automatic  
15 Steyr M40-A1 pistol, at Cliff Hudson's trailer on Old Trailer Court Road in Metlakatla.  
16 The trailer is rented by Naomi Leask, Isaac Henderson's mother. When the police  
17 arrived, witnesses reported that Isaac Henderson shot Tyler Henderson in the head with  
18 the pistol during an argument. The police observed a gunshot wound to Tyler  
19 Henderson's head. Tyler Henderson was transported to the PeaceHealth Ketchikan  
20 Medical Center by boat. At the time that this Information is being filed, the State  
21 understands that Tyler Henderson is still alive.
